



## Privacy Policy Fabulous Fat Friends

The following data controller communicates the processing of your personal data by way of this 'Privacy Policy': **Belgicactus BVBA (private limited liability company)**, with registered office in Kapellerij 6, 2260 Westerlo and registered in the Crossroads Bank of Enterprises under VAT number BE-0469.627.082 (hereinafter called: 'Belgicactus').

This privacy policy outlines the essential information that is used to process your personal data.

By providing your personal data on the website and by entering personal data in the e-mail addresses listed on this website, you declare to have taken due note of this Privacy Policy and you also expressly agree with this Policy as well as with the processing as such.

### **Article 1 – General**

1.1. For the purposes of processing personal data Belgicactus complies with the applicable "Act of 8 December 1992 on the protection of privacy in relation to the processing of personal data", as amended by the Act of 11 December 1998 and the anti-spam provisions of Book XII of the Belgian Code of Economic Law concerning the "law of the electronic economy".

1.2. In addition Belgicactus makes every effort to comply with European Regulation 2016/679 of 27 April 2016 with regard to the Protection of Personal Data (General Data Protection Regulation, or better known as GDPR) as well.

### **Article 2 – Personal data**

2.1. Personal data provided to us:

- **Category 1**, without registration: your IP-address
- **Category 2**: billing data;

2.2. The website does not use cookies to collect certain personal data.

### **Article 3 – Processing purposes**

#### 3.1. General purposes:

The Personal Data collected about you will be used solely for the following purposes:

- **Category 1:** maintaining and improving this website and the inclusion of Personal Data in anonymous statistics from which the identity of specific persons or companies cannot be deduced, with the legal grounds being the legitimate interests of Belgicactus to continually improve its Website and services;
- **Category 2:** the provision and invoicing of the services requested by you, with the legal basis being the provision of a service that was requested by you.  
You are not obliged to release your personal data, but you must understand that the provision of certain services becomes impossible if you refuse to allow the processing.

#### 3.2. Direct marketing:

If you have already been included in our mailing list for receiving marketing materials in hard copy and/or electronic format, Belgicactus may use your personal data for sending you marketing and other materials relating to the various services.

This consent can be withdrawn at any time, without justification and free of charge, by clicking on the unsubscribe link provided for this purpose. This unsubscribe link is included in every e-mail sent for direct marketing purposes.

Belgicactus will not sell, rent out or trade your Personal Information to any third party without your prior consent.

### **Article 4 – Duration of the processing**

We retain and process personal data for a period that is necessary to fulfil the purposes of the processing, depending on the contractual relationship between Belgicactus and You.

### **Article 5 – Your rights**

The following rights relating to your personal data can be exercised at any time upon simple request.

#### 5.1. Right of access and inspection:

You have the right to access your personal data at any time and free of charge.

#### 5.2. Right of correction, deletion and limitation:

You are free to communicate your personal data to Belgicactus, or not to do so. In addition you have the right to ask us to correct, supplement or delete your personal data.

### 5.3. Right of objection:

You also have the right to oppose the processing of your personal data for serious and legitimate reasons or for direct marketing purposes.

### 5.4. Right of free data transfer:

You have the right to obtain your personal data in a structured form and/or to have your personal data transferred to other data processors.

### 5.5. Right of withdrawal of consent:

Insofar as the processing is based on your prior consent, you have the right to withdraw this consent.

### 5.6. Exercising your rights:

### 5.7. Automatic decisions and profiling:

No profiling methods having detrimental automatic impact on the services received are used while your personal data are being processed.

### 5.8. Right to submit complaints:

## **Article 6 – Security and confidentiality**

6.1. We have developed technical and organizational security measures to prevent the destruction, loss, falsification, modification, unauthorized access or inadvertent notification to third parties of personal data by error, as well as to prevent any other unauthorized processing of this data.

6.2. Under no circumstances can Belgicactus be held liable for any direct or indirect damage that arises from the incorrect or unlawful use of the personal data by a third party.

6.3. You must comply with the security regulations at all times. You are therefore solely responsible for the use made of the website from your computer, IP-address and for your identification data, as well as for the confidentiality thereof.

#### **Article 7 – Access by third parties**

7.1. In order to be able to process your personal data, we grant access to your personal data to our employees.
